The Unicist Lectures help participants to see the fundamentals of a specific reality in order to be able to exert more influence on it. They might be live virtual lectures or live lectures.

Dealing with the nature of reality

Unicist lectures deal with fundamentals, unveiling the nature of reality in order to design strategies to make things happen. They are activities to foster “doing” based on the nature of reality.

Discovery of the Ontogenetic Intelligence of Nature: The discovery of the ontogenetic intelligence of nature is a breakthrough. It explains the structure of the evolution of nature. It will introduce you to the most conflictive aspect of human knowledge: the nature of evolution. Understanding evolution and its laws makes the future predictable, having certainty of error and a high probability of nearness. The consequences of this approach appear paradoxical. On the one hand, it provides the elimination of uncertainty, but at the same time it is an illusion-killer. This lecture will unveil evolution and give you a solution if you want to influence the environment.

Unicist Strategy: This is a life changing experience. This lecture on Unicist Strategy provides an introduction to the nature of strategy building and its taxonomy. The discovery of the ontogenetic intelligence of nature and the unicist theory of evolution opened the possibilities to emulate the nature of real businesses. This allowed the building of conscious strategies and the definition of maximal and minimum strategies according to the nature of the institution, the business or the individual. Unicist strategy building defines a new world of possibilities. The result in business is growth and profit.

Unicist Object Driven Organization: The Unicist Object Driven Organization is the major breakthrough in management, being at the same time a “back to basics”. UODO is the organization based on the emulation of nature. This emulation of nature allows simplifying processes according to the objectives to be achieved and the resources you can count on. This technology was born in the 80’s but, even though it was applied in many companies, it was then ahead of its time. It was needed that IT provided the tools that are available now to be able to maximize the value added by UODO. It is the model that allows an organization to maximize its market and shareholder orientation. It is also the key to grow as an institution. This lecture is an introduction towards this path.

Unicist Future Scenario Building: The unicist approach to future research is based on finding the natural structures of a reality in the past, using the hard data of the present and inferring the possible future. The probabilities of success of the projects that are being analyzed can be defined after the possible future has been defined. You will be learning about the drivers of countries’ scenarios that define the natural future environment that has to be accepted as a limit or gravitational force for your business. Unveiling the nature of countries will give you access to the global world. No value judgments, just functional behaviors.

Peter Belohlavek was born in Zilina, Slovakia, in 1944. He is the author of *The Unicist Ontology of Evolution* and models applied to Future Research and Strategy in the Social, Institutional and Individual fields. He is the creator and developer of *The Unicist Theory*, which is based upon his discovery of the ontogenetic intelligence of nature. Both his discovery and models are the base of natural laws to explain evolution. His basic background is in Economic Sciences. He developed research and studies in the fields of Management, Anthropology, Economy, Education, Epistemology, Psychology, Sociology and Life Sciences. He dedicated his life to the research of evolution in the fields of Human Behavior, Economy, Social Behavior and Management.

Main Breakthroughs: The Ontogenetic Intelligence of Nature, The Unicist Ontology of Evolution, The Unicist Logic, Unicist Methodology for the Research of Complex Systems.

The Unicist theory is the basis of modern future research and strategy. His work includes universal matters such as the Theory of Evolution, the Structure of concepts, The Laws of Evolution, and the Structure of Thoughts. Until 2009 the author has developed more than 3,000 researches, and published more than 180 books and e-books in English, French, German, Portuguese and Spanish.

Unicist Thinking for Strategy Building

The lecture on unicist thinking provides an introduction to the process to apprehend, comprehend and influence complex realities. Its double dialectical structure enables the individual to apprehend the dynamics of a reality. Unicist thinking emulates the structure of the ontogenetic intelligence of nature in order to be able to deal with it. That is why using unicist thinking individuals can approach evolution and develop strategies. This is a conscious approach to reality far beyond automatic intuitive approaches. Unicist thinking is necessary to develop strategies.

Ethical Intelligence in Business

This lecture presents one of the major breakthroughs in the field of human intelligence carried out at The Unicist Research Institute. Ethical intelligence is the basis for: 1) Added Value Generation; 2) Individuals' influence on the environment; 3) Time management; 4) Strategic planning capacity and 5) Focusing. Ethical intelligence establishes the game rules to run businesses. Different activities require different rules. If you have a lower ethics than the one that is required by the business you will be downgrading it and losing market share. If you have a higher ethics than what is required, you will lose market share and also money.

Unicist Business Mythology

This lecture is a mind-opener to deal with the culture of a business in order to influence it and make it more effective in the environment. Myths are solutions that are installed in peoples' minds. This lecture will introduce you into the structure of myths that are installed in institutions whether they are functional myths or fallacious myths. You will discover that fallacious myths are necessary to deal with the weaknesses of the organizations. This lecture will open your mind to help organizations understand their nature, integrating their mission, vision, procedures and rules by understanding and influencing their business myths.

Unicist Object Driven Leadership

We invite you to enter into the world of institutionalized leadership. Discovering the nature of leadership will allow you to understand the diverse functionalities of the different leadership styles according to divergent situations. This lecture will help you reach a new perspective in leadership that will allow you to empower your own leadership and profit from others' leadership styles. The unicist approach is based on integrating the leaders' personal actions with the objects based on the institutionalization of their role. Unicist Object Driven Leadership is a "back to basics" in leadership.

Unicist Female and Male Archetypes in Business

This lecture empowers the strategic approach to businesses. It presents the aspects of the research on female and male archetypes that belong to the application field of business. Unicist human archetypes define the ontological patterns that sustain human behavior. They allow defining the basic functionality of female and male roles in business and their complementation. This lecture gives an end to sexist discrimination providing the necessary information to integrate both the feminine and the masculine archetypical behaviors.

Although Unicist archetypes are compatible with the concept of Plato, the psychoid archetypes of Carl Jung and the Taoist conception, they are based on the ancestral structure of human's ontogenetic intelligence. This research was based on the discovery of the ontogenetic intelligence of nature. It began in 1989 and since 2006 it included Argentina, Australia, Brazil, Canada, Chile, China, England, France, Germany, India, Japan, Mexico, Spain, Sweden, USA and Venezuela.



Diana Belohlavek is currently the VP of the Unicist Knowledge Bank at The Unicist Research Institute. Her postgraduate studies were in research methodologies at The Unicist Corporate University. One of the personal interests that has influenced her professional career the most has been the study of myths from an anthropological point of view.

Unicist Object Driven Healthcare Organization

This lecture provides access to an innovative healthcare management approach. The use of objects that work as automatic pilots within processes changed the speed and security in processes. The use of object is ancient in healthcare. Remedies or drugs are objects to deliver a secure result within a complex environment which is the patient's health. The expansion of the concept "object" from therapeutics to healthcare management is a natural step that can be done because of the IT solutions that are now available.

This lecture will open the perspective from a medical approach to a perspective that goes beyond medicine.

Unicist Institutional Therapeutics

This lecture will change your vision of change management. Institutional therapeutics requires the integration of the four main perspective of cure: Surgery, Contraria contrariis curantur, Simillimum and Energetic. This four principles need to be applied to manage small changes (surgery), medium changes (contraria contrariis curantur), big changes (simillimum) and to catalyze evolution (energetic). The integration of these therapeutic principles is what allows fulfilling the goal of Change Management: "Change without Changing". In this lecture you will discover the functionality of change and how to minimize it in order to maximize results. It will be an unforgettable experience.

Unicist Patient Centered Management

This lecture provides the essential knowledge of the ethics implicit in the Patient Centered Management (PCM). The integration of roots and processes allow participants to integrate medical practice, research and management in their oneness. PCM is an object driven meta-model that works as a catalyst of the institution's processes to establish the rules for an optimum use of the organization's resources so as to satisfy patients' needs. PCM is a meta-model to provide result assurance, client orientation and secure added value.

Object Driven Quality Assurance

Envisioning quality assurance requires a mind opening attitude. It requires thinking about reality and its context to define the necessary objects to achieve the objectives. To have a reliable knowledge, in order to produce results, it is necessary to have installed redundancies in processes. Designing objects implies increasing the amplitude of the unified field one is working on. This requires a higher level of knowledge on the actual reality. It is necessary to have assured quality in order to grow. But the sound knowledge of the context is necessary in order to assure quality. Therefore this lecture works as a mind-opener.

Diego Glancszpigel graduated in Marketing in the Universidad Argentina de la Empresa (1995) and is Master in Business Administration (with orientation towards healthcare management) in The Unicist Corporate University (ex Adam Smith Open University) 1998 (graduated with honors).

He is General Manager and Director for Latin America of PAREXEL International since 2001.

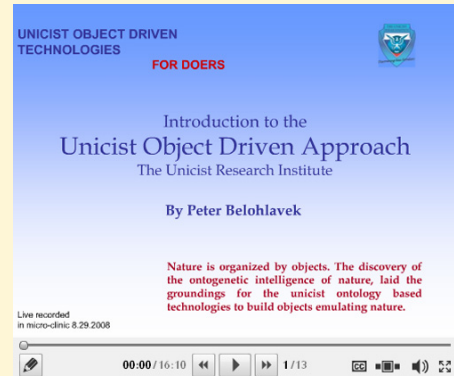
